

### Egypt Impact Lab to improve lives through evidence

Under a new collaboration, the Abdul Latif Jameel Poverty Action Lab (J-PAL) and Egypt's Ministry of Planning and Economic Development have launched a new initiative called the Egypt Impact Lab. The lab's research and policy work will revolve around top government priorities, particularly poverty alleviation through evidence-informed decision-making, as currently "the Government of Egypt is embarking on many major poverty reduction and human development initiatives," noted Alison Fahey, executive director of J-PAL MENA. By building a culture that uses evidence to inform decisions across government, the Egypt Impact Lab aims to build partners' capacity to use evidence in programme design and delivery.

The Africa Centre for Evidence, who acts as the secretariat to the Africa Evidence Network (AEN), has won a team award for engaged scholarship of a research team award. The team led by AEN chairperson Professor Ruth Stewart received recognition for their commitment to and participation in partnerships and diversity by Universities South Africa and the Human Sciences Research Council of South Africa.

Cochrane received a grant to enhance evidence-informed guideline recommendations for newborn and young child health in three sub-Saharan African countries, under the Global Evidence, Local Adaptation project. The project aims to maximise the impact of evidence for poverty-related diseases by increasing the capacity of decision-makers and researchers to use global research to develop locally relevant guidelines for newborn and child health.

# Strengthening evidence-use capacities for universities

The Strengthening Endogenous Capacities of Least Developed Countries to Access Finance for Climate Change Adaptation project was launched last month. Led by START International in collaboration with the Global Environment Facility (GEF), the United Nations Environment Programme (UNEP), and the Least Developed Countries' University Consortium on Climate Change (LUCCC), the project aims to strengthen the capacities of universities in least-developed countries (LDCs) to more effectively advise their governments on implementing climate change adaptation measures that can lead to more fully accessing international climate finance.

### INTERNATIONAL EVIDENCE

A recent London School of Economics article asserts that social science research is outperforming other fields of research in terms of policy impact. By tracking policy impacts, it is possible to produce more nuanced views of research impact outside of the dominant Anglophone research context; standard citation indicators reveal only the strength of a researcher's influence within academia.

According to a new briefing by CHEX, statutory organisations and funders are encouraged to confront their old ways of working with and thinking about evidence so they can better utilize evidence from communities, the third sector, and community organisations. CHEX draws from conversations with a wide range of people and perspectives on evidence to outline how this system level change can be achieved.

IDinsight shares a blog on their research to estimate how much value evidence creation adds to development partners' limited resources, helping them allocate them more efficiently. They have been exploring ways to thoughtfully answer this question as part of their Value of Information (VoI) work to improve how development sector resources are allocated to creating evidence.
