Evidence for policy: policy-making using science

In December 2018 the Joint Research Centre of the European Commission arranged an Evidence-Informed Policy-Making (EIPM) seminar in Pretoria in partnership with South Africa's Department of Science and Technology, amongst others. Over 100 African participants were trained to use evidence for policy-making through the lense of the food-water-energy nexus. South Africa's Minister for Science & Technology, Hon Mmamoloko Kubayi-Ngubane, delivered an opening address and urged funders in Africa to avoid duplication through coordination of research efforts. AEN members (Harsha, Carina, and Laurenz) co-facilitated a master class on evidence mapping and responsive /rapid evidence synthesis.

World Bank review of 2018

A visual representation of the challenges that the world is facing, as well as proposed solutions thereof, are provided in the form of charts by World Bank in a blog by Donna Barne and Divyanshi Wadhwa. At the end of 2018, extreme poverty worldwide was at its lowest in recorded history, although it was expected to increase in Sub-Saharan Africa. A large number of people across the world are now refugees as they have been forced to move from their countries. It is projected that by 2050, there will be twice as many people living in cities than in rural areas. Electricity access has been increasing in most developing countries and since 2011 a significant number of people have access to financial services.

INTERNATIONAL EVIDENCE

Howard White, director of the founding the International Initiative for Impact **Evaluation** (3ie), reflects on 3ie's achievements for the past 10 years, saying that it has contributed to the evidence architecture and research transparency. The current executive director, Emmanuel Jimenez mentions the importance of making evidence available to policymakers, programme implementers and beneficiaries.

In his blog, Brian Levy emphasises the importance of knowing and understanding how school governance systems work to improve learning outcomes. One way in which governance shapes learning outcomes is technical efficiency through which inputs are utilised. It is essential to know that there is no one-size fits all, hence a need to always consider context.

John Young gives a reflection on the evidenceinformed policy work in the UK and how to implement policies that work. Evidence use in the UK remains a major challenge despite the numerous efforts to promote it. The UK should learn from initiatives by developing countries such as the establishment of the Department of Planning, Monitoring and Evaluation in South Africa, which is an approach to embed evidence use in policy processes.
