Training on research communications and policy engagement

Last month, the African Institute for Development Policy (AFIDEP) and the African Academy of Sciences (AAS) hosted a training workshop on how to enhance the value of and strategies for evidence-informed decision-making (EIDM). The training consisted of practical sessions, which mainly focussed on early-to-mid-career researchers. The end goal of the training workshop was to increase the number of academic leaders advocating for EIDM in Africa and to enhance participants' commitment to being instrumental in institutionalising a culture of EIDM in their specific positions.

The Southern Voice recently released a report on the state of the Sustainable Development Goals (SDGs) in Sub-Saharan Africa (SSA). This new research focusses on the challenges facing the region in implementing the SDGs. The report emphasised the execution of three specific SDGs: education (SDG 4), energy (SDG 7), and economic growth and labour (SDG 8).

The Ghana Statistical Service introduced a five-year corporate plan to promote evidence-based decision-making, with five crucial goals to ensure that citizens are always informed about the current data trends in the country. The motivation behind the plan is that data is a very important part of democracy and the main ingredient for decision-making.

According to Newsday, there is an urgent need for more young leaders in Africa because they bring in innovative ideas to run the nation of Nigeria efficiently and sustainably. The authors pointed out the significance of relevant and appropriate evidence-based policy, which will ensure that the continent moves in the right direction.

A group of scientists at Makerere University has developed a machine that will supply policy-makers and researchers with excellent data to monitor the direction of air quality for evidence-based decision-making around air pollution. This initiative seeks to address the gap in air quality monitoring in Africa.

Evidence-use as a mechanism to support decisionmaking

In a recent Conversation article, three authors recommend six ways in which members of the civil service can support evidence-use in decision-making. There are several challenges the authors identify for civil servants in using evidence to support decision-making. Instead of merely adding more scientists to work in the field, there is a need for a 'decision-making revolution' or what the authors refer to as a transformation in thinking. As a solution, the authors urge government departments to use 'horizon scanning', consider all options, and accurately organise evidence as some strategies to support this revolution of decision-making.

INTERNATIONAL EVIDENCE

In a recent LSE Impact blog, Professor Diana Mitlin and colleagues share effective ways that academics can co-produce valuable knowledge for social movements. They point out that co-production of knowledge can be attained through examining the 'theories of change', integrating education, and dealing with status, amongst other methods.

The George Institute for Global Health in India and the Atal Bihari Institute of Good Governance and Policy Analysis (Bhopal) are collaborating to produce evidence to promote evidence-informed decisionmaking in healthcare, which will improve health services in that country. The main goal of this partnership is to inform health systems and policy decision-making through joint publications, forums, seminars, and other methods of publication.

Have you ever wondered if it is possible to have value-free evidence? A PhD candidate and research fellow at the University of Stavanger, Jason Deegan, highlights the importance of contextualising the methods in which evidence-based policy is used and understood. The policy-making process is not exclusively objective but political in nature; hence, it is essential to incorporate values to attain the set goals.
