

Africa Evidence Network - South African Branch Launch

The South African branch of the Africa Evidence Network (AEN) was officially launched on 28 February at the University of Johannesburg (UJ). The launch marked a milestone in the development of the AEN, which has secured funding by DFID via the UJ-BCURE programme for the establishment of country-specific branches and the hosting of two continent-wide colloquiums to provide



capacity-building and capacity-sharing opportunities. **A video** of the launch, which was attended by distinguished guests from government and academia, is available.

Recent reports account for the performance of the Department of Performance Monitoring and Evaluation (DPME) in South Africa and its attempts to increase the use of evaluation within government agencies. Among other, **the reports** analyse the National Evaluation Strategy – a major initiative of the DPME – two years after its adoption in parliament and provide **findings** of a survey on the perception of high-level policymakers in South Africa regarding M&E. The AfDB recently highlighted the importance of M&E in a working paper entitled 'Patterns and Influences in the Supply and Demand of Evaluation and Monitoring in Uganda's Public Sector over the Past Two Decades'. The **paper** gives an historical account of M&E in the Ugandan political system and concludes that the demand-side conditions seem to be decreasing more recently in Uganda.

'Tools for Bringing Research to Policy Makers', was the theme of a recent **panel session** on the final day of the 8th Annual PopPov Conference on Population, Reproductive Health and Economic Development held in Nairobi. A summary of the debate is provided by Peter da Costa, the facilitator of the panel.

Hugh Waddington's recent **blog post** on 'How much evidence is enough for action? The value of systematic reviews and the totality of evidence' sheds light on how willing the international development evidence community is to discuss whether one of its flagship programmes is as evidence-informed as it appeared.

A new **blog post** by Kirsty Newman tackles the question of how to bring research rigour and context together. She finds that research quality and research relevance are two important issues and the fact that some research is not contextually relevant does not in any way negate the fact that some research is not good quality.
