




Emerging EIDM leader_Gloria Anderson: why I fell in love with EIDM

AFRICA EVIDENCE WEEK – BLOGS


During Africa Evidence Week 2021, the most popular way in which organisations participated was through blogs on evidence-informed decision-making: we promoted fifteen blogs in just five days!
