### PRIMARY HEALTH CARE (PHC) AND ADULT HOSPITAL LEVEL STANDARD TREATMENT GUIDELINES AND ESSENTIAL MEDICINES LIST

- The following chapters have been reviewed and *ratified for publication*, with the respective NEMLC report and relevant medicine review(s):
  - **PHC Chapter 13: Immunisations** Following updates in response to comments from the clinical editorial reviewer, NEMLC ratified the chapter for *publication*. The updated chapter with supporting NEMLC report has been uploaded on the Knowledge Hub, url: <u>https://www.knowledgehub.org.za/elibrary/primary-healthcare-phc-standard-treatment-guidelines-and-essential-medicines-list-south</u>
  - Adult Hospital Chapter 9: Systemic and healthcare associated infections NEMLC ratified the chapter for *publication*.
- The following have been reviewed and ratified *for external comment,* with the respective NEMLC report and relevant medicine reviews:
  - **PHC Chapter 20: Pain** NEMLC ratified the updated chapter for *external comment*, following editorial amendments by the Expert Review Committee (ERC).
  - **PHC Chapter 22: Medicines used in palliative care** NEMLC ratified the updated chapter for <u>external</u> <u>comment.</u>
  - Adult Hospital Chapter 24: Medicines for palliative care NEMLC ratified the updated chapter and review for external comment.
  - **Adult Hospital Chapter 26: Pain** NEMLC ratified the updated chapter for *external comment*, following editorial amendments by the ERC.
  - The following medicines were reviewed by NEMLC:
    - Olanzapine for refractory nausea and vomiting NEMLC recommended that oral, oro-dispersible & IM olanzapine be used in adult palliative care patients with nausea and vomiting not responding to metoclopramide, as a replacement to haloperidol. The review was ratified for <u>external comment</u>.
    - **Hyaluronidase for cataract surgery** An evidence review on the use of hyaluronidase for cataract surgery was presented to NEMLC. The Committee suggested a conditional recommendation for the use of hyaluronidase as an adjunct to anaesthesia for peri-orbital block. Hyaluronidase will be added to the list of medicines included in the STG for use during eye surgery.
    - Cabotegravir Long Acting (CAB-LA) as pre-exposure prophylaxis for HIV The budget impact analysis (BIA) and cost-effective analysis on the use of CAB-LA for pre-exposure prophylaxis of HIV was presented to NEMLC. NEMLC acknowledged the efficacy and safety profile of CAB-LA, however, a final recommendation could not be confirmed until such time that a local price for CAB-LA is announced.
